1. The Democratic Socialist Republic of Sri Lanka has received financing from the **Asian Development Bank (ADB)** toward the cost of the **Health System Enhancement Project - Additional Financing**, and it intends to apply part of the proceeds of this financing to payments under the contracts named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The Ministry of Health and Mass Media (the Purchaser) invites sealed bids from eligible bidders for the procurement of the following goods. A brief description of the types of goods is below:

3. **The Successful Bidder** must deliver Goods to the locations mentioned in the delivery and completion schedule in the Bidding Document. Also, delivery, installation, and commissioning must be completed within 120 days from the signing of the contract and introductory training to the technical staff on the use of the equipment should be arranged before the commissioning.

4. **Open Competitive Bidding** (OCB) will be conducted in accordance with ADB's Single Stage: Single Envelope bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document. The eligibility rules and procedures of ADB will govern the bidding process.

5. Only eligible bidders with the following key qualifications should participate in this bidding and the qualification criteria are more completely described in the Bidding Document:

- Successful completion as the main supplier within the last 7 years of at least one Medical Equipment contract valued as follows:

- The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods required by the Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply) of the Bidding Documents;

- Historical Financial Performance** - Submission of audited financial statements for the last three years (2021/2022, 2022/2023, and 2023/2024) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year, calculated as the difference between total assets and total liabilities, should be positive.
- Cash flow Capacity:** Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement, which is LKR 780 Mn for Lot 1 and LKR 420 Mn for Lot 2 separately.

7. A pre-bid meeting shall take place at **1130 Hrs. on 13 January 2026** at the above address, conducted by the Employer. All bidders are strongly advised to attend this pre-bid meeting.

8. To purchase the Bidding Document in English, eligible bidders should submit a written request/application to the address above requesting the Bidding Document for the **Procurement of Linear Accelerator (Top End) 1 No. with SGRT System (Immobilization Equipment optional) and High End Bracky Therapy after Loader Unit + Accessories – 01 No. for NH Galle [G35.2(AF)]** for the Health System Enhancement Project – Additional Financing and pay a nonrefundable fee **on or before 1500 Hrs. on 29 January 2026**.

The method of payment will be in the form of a bank draft in favor of the **“Secretary, Ministry of Health and Mass Media, Health System Enhancement Project – Additional Financing (Counterpart) – A/C 7040799”** or in cash, from **0900 Hrs. to 1500 Hrs.** on working days or pay by direct deposit to a bank account number **7040799** at Bank of Ceylon.

10. The Bidding Document may also be sent by airmail for overseas delivery and surface mail or courier for local delivery with an additional fee **of US\$100 or equivalent in Sri Lankan Rupees**, respectively in addition to the nonrefundable fee stated under para 8. No liability will be accepted for loss or late delivery.

11. Bids shall be delivered to the address given in para 6 above on or before **1100 Hrs. on 30 January 2026** together with the Bid Security as specified in the bidding document. If the Bid Security is submitted in a form of a Bank Guarantee, it shall be issued using the format given in the Section 4 of Bidding forms by a Commercial Bank approved by the Central Bank of Sri Lanka in favor of “The Project Director - Health System Enhancement Project”. Late Bids will be rejected and returned unopened.

12. The Bids shall be valid for 120 days from the date of bid opening. The Bid Security shall be valid for 148 days from the date of bid opening.

13. Bids will be opened immediately after the deadline for bid submission in the presence of Bidder's representatives who choose to attend.

14. The Ministry of Health and Mass Media or the Health System Enhancement Project - Additional Financing will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
