This has reference to the letter issued by the Director, International, bearing No. IB/C/09/2025 dated 9 October 2025 (copy attached), granting concurrence for Dr Farrukh Qureshi to continue his duties as the Medical Officer (Non-Communicable Diseases) at the WHO Country Office, Sri Lanka, for a further period of 12 months commencing 7 December 2025.

We wish to inform you that the United Nations Laissez-Passer (UNLP) bearing No. AUNB34237, issued to Dr Farrukh Qureshi, will expire on 23 July 2026. As the validity of this UNLP is insufficient, the Ministry of Foreign Affairs, Foreign Employment and Tourism has extended the residence visas of Dr Qureshi and his family members only up to 23 May 2026.

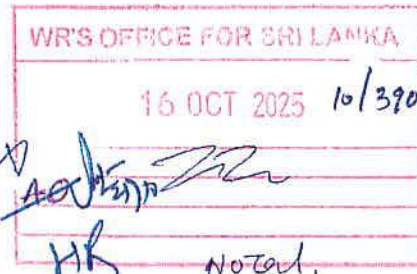
