



INVITATION FOR BIDS (IFB) 2026_02

MINISTRY OF HEALTH, INDIGENOUS MEDICINE AND PROBATION AND CHILD CARE SERVICES, NORTHERN PROVINCE



1. The Democratic Socialistic Republic of Sri Lanka has received a grant from the Government of the **Republic of India** towards the cost of **Construction and Supply of Medical Equipment for Accident and Emergency Unit at District General Hospital, Mannar** and intends to apply part of the proceeds of this grant to payments under the contract for **Construction of Accident and Emergency unit at District General Hospital, Mannar**
2. The *Chairman, Provincial Ministry Procurement Committee* on behalf of the *Secretary, Ministry of Health, Indigenous Medicine and Probation and Child Care Services, Northern Province, Health Village, Pannai, Jaffna* now invites sealed bids from eligible and qualified bidders for construction works listed in the **Table below. All relevant details are listed in the same Table.**
3. Bidding will be conducted through ***International Competitive Bidding (ICB)*** Procedure and **restricted to eligible Bidders from India and Sri Lanka as per Funding Agreement.**
4. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have the following requirements,
 - i. For **Domestic Bidders, Bidders must be registered with the Construction Industry Development Authority (CIDA)** in the field of building construction for grade mentioned in the table below.
 - ii. For **Foreign bidders, No CIDA registration is required**, but in case of **Foreign Bidder is selected for contract award, particular bidder shall obtain temporary registration** as a foreign contractor under Construction Industry Development Act No. 33 of 2014 and other required registrations under the laws of Sri Lanka.
5. Any of the following party who wishes to submit a bid, shall register himself at the Department of Registrar of Companies (www.drc.gov.lk (e-ROC))as per the Public Contracts Act, No. 03 of 1987 for every public contract value exceeding Sri Lankan Rupees Five million (LKR 5,000,000.00).
 - i. An agent, sub-agent, representative or nominee must be registered prior to the closing of the Bid
 - ii. If the Bid applicant and Bidder is the same party he must be registered prior to award of the bid
6. Qualification requirements to qualify for contract award are specified on **Bidding Data (Section 02), Contract Data (Section 04) and Schedule (Section 09) of Procurement Document (SBD 2)**

The method of payment will be **Cash/ Digital and cash payment shall be made directly to shroff or to the Bank account of Ministry of Health, Indigenous Medicine and Probation and Child Care Services, Northern Province (MoHIMP&CC, NP)**.

All bank Charges shall be borne by bidder and proof of remittance (Copy of TT) is required along with written request before 14 days to the Bid Closing Date to issue the Procurement Document By Courier Service. No liability shall be borne by **MoHIMP&CC, NP on loss or late delivery. Bidder shall deposit another Sri Lankan Rupees. 5,000.00 as Courier Charge.**
