Amendment for Circular of Charges for Paying Ward Facilities and Healthcare Services for Sri Lankan Citizens and Non-Citizens in Government Hospitals in Sri Lanka

It has been observed that the provision relating to the deposit payment required from patients admitted to paying wards, as stipulated in Circular No. 01-31/2026, requires amendment to ensure proper financial administration in hospitals.

Accordingly, the provision under the heading "Revised Prices of Paying Wards" in the above-mentioned circular is hereby amended as follows:


Existing Provision	Amended Provision
"The deposit amount shall be calculated as three times the applicable room charge."	The deposit amount shall be determined based on the category of treatment as follows:

Deposit Amounts

Category of Treatment	Deposit Amount (Rs.)
Medical Treatment	- 22,500.00
Surgical Treatment	- 27,000.00

The amended charges shall be implemented with effect from the date of signature of this amendment letter.

All other provisions of the above-mentioned circular shall remain unchanged.
